- YVSC to develop posters/flyers and rack cards to be featured at the Yampa Valley Regional Airport before the start of Thanksgiving travels. Material to be shared at October meeting.
- Good Traveler program has been shared with the Bob Adams airport. Counselor Garey to follow up in a couple weeks.

- Counselor Garey motioned to amend the agenda. Mathew moved to approve the recommended scope of work subject to finalization of partner budgets. Sarah seconded. All in favor. No opposition with Commissioner Macys abstaining from the vote.

4. Program Management Updates (YVSC)

2021 International Building Code update

- City Council did a first read and option number 5 language for outdoor snowmelt was adopted no limitations on size nor power source for commercial zones.
- Tim W. motioned to take a position via a letter to City Council from the CAP Board requesting that City Council supports the CAP Energy recommendation that states 'All CAP governments approve the IECC 2021 building code and adopt planning/zoning regulations that minimize outdoor energy use unless it is provided by a low/no carbon energy source or offset by 100% renewable energy.'
- Motion seconded by Commissioner Macys. All in favor. No opposition. Passes unanimously with recusal from Counselor Garey and Sarah.

Discussion of what we are proposing for the Working Group meetings

- Working Groups will meet quarterly to review progress made on current CAP-related initiatives and recommendations using trackers developed by YVSC.
- Tracking can be both qualitative and quantitative.

5. CAP Annual Report Update

- Include goals for 2024. YVSC to reach out to municipal partners for input on climate wins.
- YVSC to prepare draft report for October meeting
